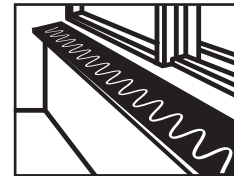

APPLICATION INSTRUCTIONS

Apply in strips in a wave-like fashion in a 1/4-inch bead for small birds, 3/8-inch for medium birds and 1/2-inch for larger birds. For wider areas, more than one bead may be necessary. To remove, use scraper and then wipe the area with soap, water and a rag. Do not apply in rainy weather or over wet surfaces. Best if used within 3-4 days of fair weather after application.

1. Cut tip of tube off with cutters.
2. Screw nozzle on tip of tube and cut nozzle 1/2 way down.
3. Load and lock tube into caulking gun.
4. Use personal protection equipment (PPE) with all applications.
